This is a targeted course, not a general introduction to the CAMEO® Suite. Class size is limited to 20 students to maximize instructor access and interaction.

- Importing EPCRA Tier II data into CAMEO DM
- Utilizing CAMEO DM to create a customized Facility planning document
- Exploring CAMEO Chemicals and its connection to CAMEO DM
- Separating Tier II Facilities into groups (e.g., RMP, EHS and non-EHS) and Mapping in MARPLOT®
- Importing critical infrastructure mapping layers into MARPLOT®, such as hazmat transportation routes
- Creating 'hazard zones' around facilities
- Evaluating potentially affected populations and infrastructure in hazard zones
- Exporting information to a spreadsheet, map, and document
- Adding attachments to a CAMEO DM Facility record
- Maintaining and sharing information
